INSTRUCTIONS

NOTES

1. **DESCRIPTION OF LAND**
 Lot and Diagram/Plan/Strata/Survey-Strata Plan number or Location name and number to be stated.
 Extent - Whole, part or balance of the land comprised in the Certificate of Title to be stated.
 The Volume and Folio or Crown Lease number, to be stated.
2. **STAMPING DETAILS**
 When completed, this Discharge form must be assessed by the Commissioner of State Taxation to determine if a transfer has been effected and if stamp duty is payable.
3. **MORTGAGEE DIVESTING**
 State full name or names of the Mortgagee or Mortgagees Divesting.
4. **MORTGAGE NUMBER**
 State DOLA registration number of the Mortgage being partially discharged.
5. **PART OF PRINCIPAL SUM**
 State in figures the part of the principal sum secured by the mortgage, being discharged.
6. **MORTGAGEE(S) REMAINING**
 State the full name of the Mortgagee(s) remaining after this discharge. State how the remaining Mortgagee(s) will hold their share in the Mortgage, e.g., as joint tenants or as tenants in common, if tenants in common specify shares.
7. **MORTGAGEE'S EXECUTION**
 All Mortgagees, (that is the Mortgagee(s) Divesting and the Mortgagee(s) remaining), **must** sign this Discharge. A separate attestation is required for every person signing this document. Each signature should be separately witnessed by an Adult Person. The full name, address and occupation of the witness **must** be stated. Execution by a corporation or body corporate must be in accordance with the Corporation Act.
